2.3 Chinese Automobile Market in 2010

2.3.1 Overview

In 2010, Chinese automobiles witnessed **** million and **** million in its full-year production and sales, year-on-year up by 32.44% and 32.37% respectively. Of which, **** million and **** million respectively for the passenger cars, growing by 33.83% and 33.17% separately; and **** million and **** million for commercial vehicles, rising by 28.19% and 29.90% correspondingly. So all the models achieved all-round progress in 2010 and the automobiles production and sales kept the hot trend in 2009, with automobile population nearly **** million and a higher market share of the self-owned brand.

3.4 Chinese Industry

In the auto wiring harness industry of China, Japanese enterprises grasp 60% market share, following by the counterparts from South Korea including YURA, Kyungshin Industrial and Yujin which occupy 15% altogether. It had 42 auto wiring harness manufacturers whose revenue surpassed RMB100 million in 2009, among which including only five domestic ones, namely, Tianhai Group, Huguang, Nantong Unistar, JAC Xinfa and Brilliance Taian. And the last two ones are associated with automotive manufacturers while Nantong focuses on coaches.







4.3 Yazaki

Established in 1941, Yazaki has 437 branch offices in 39 countries. There are 157,100 employees in the company, of which, 22,000 works in Japan. Yazaki is the largest private unlisted company in the world. The fiscal year of the company ends with late June. As the world's biggest automotive wiring harness manufacturer, the auto parts business represents 83% of its revenue. Meanwhile, the company also engages in the production of auto electronics, auto instruments, auto traveling data recorders, taximeter as well as wires.

In 2011, Yazaki investigated Xiaogan City in Hubei Province for the investment of new base which has not been confirmed yet.



4.3.1 Tianjin Yazaki Automotive Parts

Tianjin Yazaki Automotive Parts, one of the enterprises invested by Yazaki and registered in China, was founded in 1988 with the registered capital of US\$19.634 million. Located in Tianjin Economic & Technological Development Zone, the company presently possesses the land area of 110 thousand m² and over 4000 employees.

It set up Chengdu Branch of Tianjin Yazaki Automotive Parts in March 2000, and the Branch expanded the new factory in October 2004. Changchun Branch of Tianjin Yazaki Automotive Parts was established in August 2004 with the floor area of 17000m², and it mainly supplies for FAW Car Co., Ltd. In January 2007, Cangzhou Branch of Tianjin Yazaki Automotive Parts was founded, and the Phase I project of 10070m² standard workshop was put into operation and the 6 production lines practiced normal production in 2008; the Phase II project of 13000m² standard workshop acquired the acceptance of main work in March 2009 and was officially put into operation in that July. The revenue of Tianjin Yazaki Automotive Parts registered RMB150 million or so in 2010.

Cangzhou Branch of Tianjin Yazaki Automotive Parts characterizes the gross investment of RMB300 million (US\$40 million), the land area of 66mu, and the annual production scale of 400 thousand sets of automotive wiring harness. Promisingly, the revenue can reach RMB600 million in 2011, the annual profit & tax will hit RMB36 million, and more than 2000 jobs will be provided. The product markets of the project currently cover BBDS, SGM, Zhengzhou Nissan, etc., and they have been exported to North America after 2009.

4.3.2 Hangzhou Yazaki Automotive Parts

Established in February, 2002, Hangzhou Yazaki Automotive Parts is a self-owned Japanese enterprise under Yazaki who boasts over 430 factories in 38 countries and more than 180 thousand employees and it has set up 16 factories with more than 30 thousand employees in China. With the registered capital of US\$45 million and the total investment of US\$120 million, Hangzhou Yazaki Automotive Parts is specialized in the production of such components as auto wires, instruments, switch groups, central electric controller, and socket connectors.
