

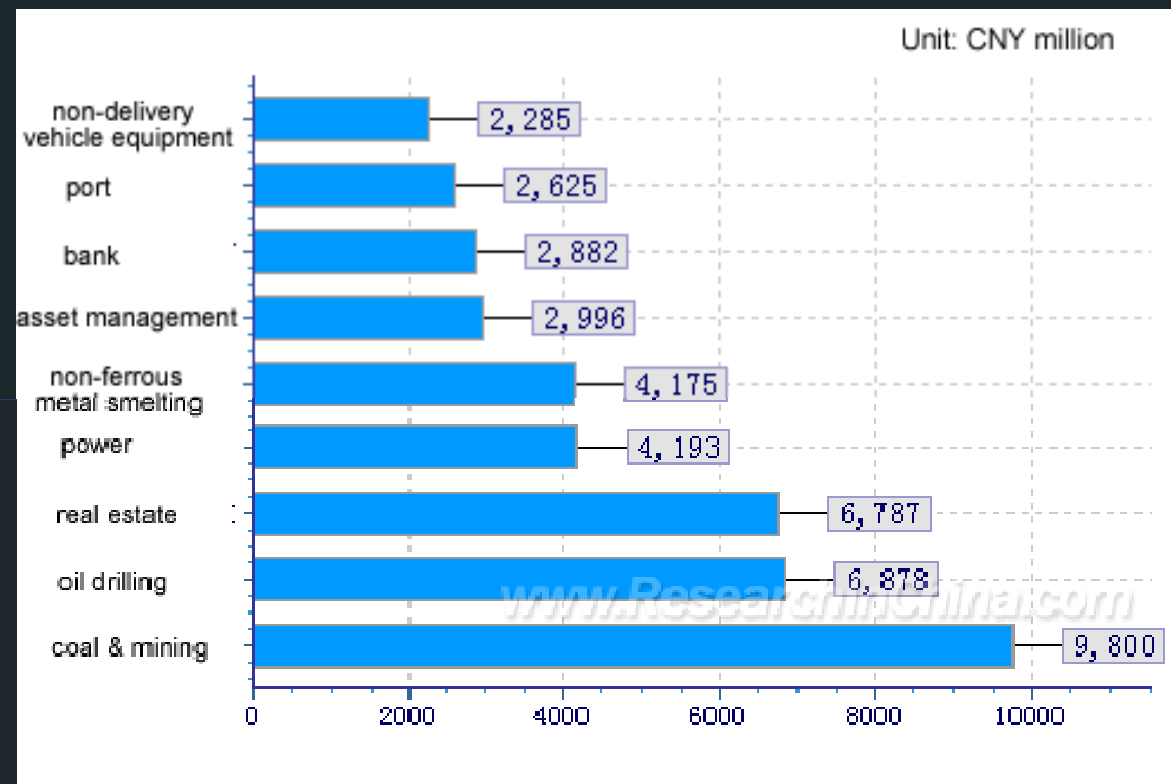
Quarterly M&A and Share Participation Report of China Stock Listed Companies, 3Q 2008



The data of this report is sourced from ReportKing, a database of investment projects regarding china stock listed companies, which collects more than 40,000 pieces information of investment project happened from 2000 to 1H 2008, providing the project details like investment region, investment purpose, target industry, players, planned capital etc.

In 3Q 2008, 184 activities of M & A and share participation regarding china stock listed companies were revealed, down 7.1% than the same period of 2007, the total value of those 184 activities was CNY 29.306 billion, up 156.7% than the same period of 2007.

The five biggest activities took place in 3Q 2008 were as follows:

- CNPC acquires Sun World Co., Ltd with a cost of CNY 6.88 billion;
- China Shipping Container Lines Co., Ltd. (CSCL) acquires China Shipping Terminal Development Co., Ltd with a cost of CNY 2.6 billion;
- Zoomlion Heavy Industry Science & Technology Development Co., Ltd acquires CIFA with a cost of CNY1.06 billion.
- Gezhouba Corporation purchases share of Hu Han Rong Railway Hubei Co., Ltd. With a cost of CNY1.6 billion;
- SINOCHEN International Corporation acquires Singapore GMG Global Ltd with a cost of CNY1.34 billion.
