

China Medical Sales and Medical Device Market Report, 2008



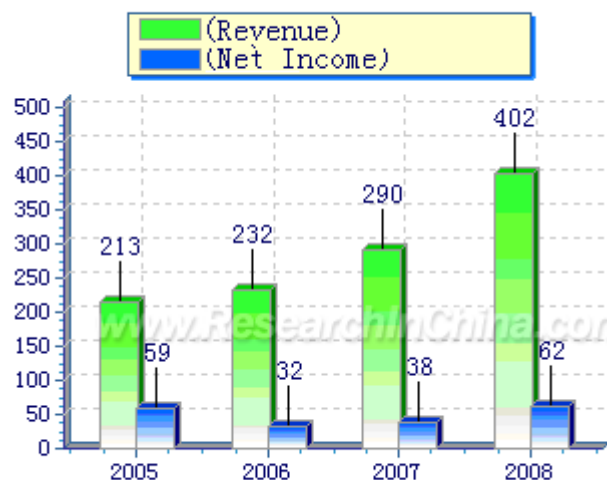
In the recent years, Chinese medical device market developed rapidly. During Jan to Nov 2008, 915 medical device companies were together realized a sales revenue of CNY 63.6 billion, accounting for 9.69% of the total medical sales revenue of CNY 656.1 billion. During 2004 to 2008, the sales revenue and total profit of medical device companies averagely increased by 30%.

In the year of 2008, the sales value of China's top 100 chain retail drug companies amounted to CNY 52.1 billion, increased by CNY 7.1 billion compared to 2007, or a growth of 15.85%.

This report describes the status quo and development trend of medical sales and medical device market in china, as well as 14 key medical device and medical sales companies including their operations and revenue, project investment, business structure and development strategies etc.
